I have been provided the opportunity to view and familiarize myself and shall strictly adhere with each of the foregoing Gulf County Ordinances, the Gulf County pamphlet and related materials stating the rules and regulations concerning the operation of permitted vehicles on the designated beaches of Gulf County (a copy of each of these documents are available on the Gulf County website, Gulf County TDC website, as well as a copy available for review in the Gulf County Tax Collectors Office); and
- I have reviewed and acknowledge the fines and penalties that may be imposed for my violation of the Gulf County regulations for conditional beach driving; and

'MUST HAVE PERMIT to drive only on approved beaches.


'Speed limit is strictly 15mph.

The beach driving permit fees shall be structured as follows:

i.	Annual Beach Driving Permits – Gulf County Resident	\$30.00
ii.	Non-Homestead Gulf County Property Owner	\$100.00
iii.	Annual Beach Driving Permits – Non-County Resident (Current county quota not to exceed 200 per annum of out of county permits as established by the Board of County Commissioners on first come first permitting basis per annum)	\$500.00
iv.	Senior Citizens (65 or older)/ Disabled Citizens that are documented Gulf County Residents special exemption and one-time administrative fee (per vehicle).	\$3.00
v.	Annual commercial driving permits issued to local Gulf County businesses for beach rental vehicles shall have the annual fee and quota allotment of permits determined by the County Administrator.	\$200.00

vi. Any and all future annual permit fee adjustments and rate increases or decreases shall be introduced through recommendations by the administration and ratified by resolution and authorizing vote and policy of the Board of County Commissioners in open public meetings.
